b. North Central men's basketball team wins first-ever home game

On November 9, 2022, Drew Kochanny of the Petoskey News-Review reported on the historic moment for NCMC's athletic program which came over the weekend. The men's and women's basketball teams both opened their 2022-23 season, the first-ever for both programs. Playing in a weekend series in Benton Harbor, the men's team opened with a 62-59 victory over Lake Michigan College on Friday. The victory also came as the first-ever win for head coach Jeff Corcoran at the collegiate level.

Skylar Crudup led with 16 points, seven rebounds and four assists, while Dai'Montae Rembert scored 15 points and pulled down nine rebounds. Josh Adim also added 12 points and three assists, Byron Bishop had 10 points and nine rebounds and Julius Sith had five points, six rebounds and three steals. Wolverine native Max Nelson also finished the game with seven rebounds and a pair of assists.

c. NCMC retired Art instructor displays Rambler Wheel

On November 4, 2022, Karly Graham with the Petoskey News-Review reported on retired North Central art instructor Doug Melvin.

Doug Melvin made his first Rambler Wheel for Boyne City Middle School nearly a decade ago. During a snowmobile sale, the school's principal saw some of Melvin's work and asked if he'd make the school a sculpture of the logo. By then, Melvin had retired after spending 30 years teaching art at NCMC.

The newest Rambler Wheel sculpture made by Doug Melvin is on display outside the new Boyne City Public Schools fieldhouse.

d. MCCAA Volleyball – Two Timberwolves earn All-Conference Honorable Mention

The Michigan Community College Athletic Association announced the 2022 Volleyball All-Conference awards on November 8, 2022. First year players Brooklynn Besteman (Rudyard, MI/Rudyard) and Jackie Brinkman (Bay City, MI/Garber) both earned Honorable Mention in the MCCAA-Northern Conference.

a. On November 18, 2022, NCMC Dedicated Petoskey Plastics Arena

A ribbon-cutting was held during NCMC's inaugural home basketball game on Friday, November 18th. The arena was named in honor of lead donor, the Associates of Petoskey Plastics, whose gift helped launch North Central's varsity athletic program. The ribbon-cutting took place during halftime of the women's game against Mott Community College.

Petoskey Plastics Arena features a new, regulation-size wooden court. Installed by Kuhn Specialty Flooring of Beverly Hills, Mich., during the summer, the Connor flooring system consists of maple sourced from Michigan's Upper Peninsula. Also new to the arena are state-of-the-art Daktronics scoreboards donated by the Kroeger-Mainland Foundation, a fully equipped athletic training room sponsored by Kevan and Wynne Lawlor, and Interkal spectator seating for 300 fans.

Petoskey Plastics, the Kroeger-Mainland Foundation, the Lawlors and more than 30 other corporate and private donors were recognized for providing essential support to NCMC Athletics. The first home basketball game provided an exciting opportunity to dedicate the arena and honor the donors who made it possible.

"This venture would not have been possible if not for the generous donors and wonderful community partners who helped us launch our athletic program," Antonishen said. "Their gifts are allowing us to provide new and beneficial opportunities to our students, fans and the community in a way that we've never seen before at NCMC."

WHEREAS, during his time at North Central Michigan College, Trustee Millard has provided exemplary service in a variety of positions – serving as Chairman of the Board of Trustees from September 20, 2011 to May 24, 2022, and serving on the Bylaws and Policy Committee, the Curriculum Committee, and the Personnel Committee; and

WHEREAS, during his time at North Central Michigan College, Trustee Millard's service was monumental to many accomplishments such as beginning the Early College programs with Petoskey, Boyne City and Gaylord; launching the Career Development Center with LTBB Odawa with the SEDS Grant support; and securing Distance Delivery approval from HLC, and reaching the designation of Achieving the Dream Leader College;

WHEREAS, Trustee Millard's contributions were instrumental to launching the Mobile Fab lab, renovating the library in 2017, HESC construction, construction of the Harris Sculpture Garden, beginning club sports, and implementation of the Campus Cupboard Food Pantry; and

WHEREAS, Trustee Millard was part of awarding the 10,000th Associate degree earned from North Central Michigan College, and awarding the 1st Honorary Degree to Paul Keiswetter in 2019; and

WHEREAS, Trustee Millard played an important role in the successful Building Tomorrow Together campaign which provided the college with critical funding for scholarships, student success resources, technology and innovation, and the newly renovated Borra Learning Center; and

WHEREAS, during his time at North Central Michigan College, Trustee Millard played an important role in the adoption of the Timberwolf mascot and the launch of Intercollegiate Athletics (basketball, volleyball, cross county and eSports); now therefore, be it

RESOLVED, that the Board of Trustees of North Central Michigan College formally extends to Phil Millard its sincere appreciation for his loyalty, many contributions, and dedication to our students as evidenced by this resolution; be it further

RESOLVED, that a copy of this resolution of recognition appears in the minutes of this meeting of the Board of Trustees, so that this heartfelt tribute of respect and gratitude will be included in the permanent records of this College.
